ORDER:

In the Government Order 1st read above, the Government have accorded administrative sanction for a sum of Rs.25.588 Crore and financial sanction for a sum of Rs.12.794 Crore as 1st instalment for implementation of the following projects of the Director of Horticulture and Plantation Crops under National Agriculture Development Programme / Rashtriya Krishi Vikas Yojana 2020-21.

2. In the letters second read above, the Government of India have released a sum of Rs.40.00 Crore instead of Rs.82.08 crore as its Central Share [(SCSP - Rs.9.50 Crore) + (General – Rs.30.00 Crore) + (TSP - Rs.0.50 Crore)] of second instalment for the year 2020-21 for National Agriculture Development Programme / Rashtriya Krishi Vikas Yojana in the funding pattern of 60:40 between the Central and the State Governments. By adding the corresponding 40% State share of Rs.26.666 Crore, the total allocation works out to Rs.66.666 Crore.

3. Based on the above partial release made by the Government of India, in the letter 3rd read above, the Executive Director, Tamil Nadu Watershed Development Agency has prioritised and recommended the following projects of the Director of Horticulture and Plantation Crops to the tune of Rs.6.0302 Crore as 2nd instalment release under Rashtriya Krishi Vikas Yojana 2020-21:-

In the letter 4th read above, the Director of Horticulture and Plantation Crops has sent the Head of Account wise prioritized project proposal in consultation with the Executive Director, Tamil Nadu Watershed Development Agency to the Government with a request to accord financial sanction for a sum of Rs.6.0302 Crore as 2nd instalment for implementing the PP.Nos.18.19, 18.20, 18.21, 18.22 and 18.23. under Rashtriya Krishi Vikas Yojana – RAFTAAR 2020-2021.

5. The Government after careful examination of the proposal of the Director of Horticulture and Plantation Crops, hereby accord financial sanction for a sum of Rs.603.02 Lakh (Rupees Six Crore Three Lakh and Two thousand only) as second instalment for implementation of the PP.Nos. 18.19, 18.20, 18.21, 18.22 and 18.23 to the Director of Horticulture and Plantation Crops, under National Agriculture Development Programme / Rashtriya Krishi Vikas Yojana for the year 2020-21, subject to the condition that under no circumstances any deviation from the decision of the State Level Sanctioning Committee is permitted. The funding pattern of the scheme is 60:40 sharing basis between the Central and the State Governments.

6. The amount sanctioned in para.5 above shall be debited to the Heads of account annexed to this order.

7. The Director of Horticulture and Plantation Crops is authorized to draw and disburse the amount sanctioned in para 5 above to the Concerned.

8. The Director of Horticulture and Plantation Crops is permitted to fix the physical target based on the need and potential of the districts.

9. The Director of Horticulture and Plantation Crops and the Executive Director, Tamil Nadu Watershed Development Agency shall strictly adhere to the instructions issued in the Government Order 1st read above.

10. This order issues with the concurrence of the Finance Department vide its U.O.No.2907/Fin(Agri)/2021, dated 29.01.2021.


