ORDER:

In the Government Orders 1st and 2nd read above, the Government have accorded administrative sanction for a sum of Rs.25.5880 Crore and financial sanction for a sum of Rs.18.8242 Crore in two instalments for implementation of the projects of the Director of Horticulture and Plantation Crops, under Rashtriya Krishi Vikas Yojana for the year 2020-2021as follows:-

- 2. In the letters 3rd read above, the Government of India have released a sum of Rs.42.08 Crore as its Central Share [(SCSP Rs.11.91 Crore) + (General Rs.29.51 Crore) + (TSP Rs.0.66 Crore)] as balance release of second instalment under National Agriculture Development Programme / Rashtriya Krishi Vikas Yojana for the year 2020-21. By adding the corresponding State share of Rs.28.05 crore, the total allocation works out to Rs.70.13 Crore.
- 3. Based on the release made by the Government of India, in the letter 4th read above the Executive Director, Tamil Nadu Watershed Development Agency, has recommended to sanction the balance funds for the projects of the Director of Horticulture and Plantation Crops, to the tune of Rs.676.38 lakh being balance amount of 2nd instalment release for implementation of the following projects:-

- 7. The Government after careful examination of the proposal of the Director of Horticulture and Plantation Crops, hereby accord financial sanction for a sum of Rs.658.44 Lakh (Rupees Six Crore Fifty Eight Lakh and Forty Four Thousand only) being the balance amount of second instalment for implementation of the PP.Nos. 18.18, 18.20 and 18.22 to the Director of Horticulture and Plantation Crops, under National Agriculture Development Programme / Rashtriya Krishi Vikas Yojana for the year 2020-21, subject to the condition that under no circumstances any deviation from the decision of the State Level Sanctioning Committee is permitted. The funding pattern of the scheme is 60:40 sharing basis between the Central and State Governments. Balance amount of Rs.17.94 lakh will be released during 2021-2022.
- 8. The Government also accord permission to revise the sanction of funds done in the Government Order first read above, based on Government of India release, allocated for Individual Based Subsidy and Major Works, for General, SC and ST as detailed at para.6 above.
- 9. The amount sanctioned in para.7 above, shall be debited to the Heads of account annexed to this order.
- 10. The Director of Horticulture and Plantation Crops is authorized to draw and disburse the amount sanctioned in para.7 above to the Concerned.
- 11. The Director of Horticulture and Plantation Crops is permitted to fix the physical target based on the need and potential of the districts.
- 12. The Director of Horticulture and Plantation Crops and the Executive Director, Tamil Nadu Watershed Development Agency shall strictly adhere to the instructions issued in the Government Order 1st read above.
- 13. This order issues with the concurrence of the Finance Department vide its U.O.No.15948/Fin(Agri)/JS(DS)2021, dated 26.03.2021 the issuance of this order does not need clearance of Election Commission of India as per Finance Department letter No.683/B.Coord/2021, dated 17.3.2021.
