ORDER:-

In the letter first read above, the Government of India had approved the Annual Action Plan 2019-2020 of National Horticulture Mission (NHM) under Mission for Integrated Development of Horticulture (MIDH) at an outlay of Rs.163.333 crore in the funding pattern of 60:40 between the Centre and State, and communicated the approved physical and financial target for each component under AAP -2019-2020.

- 2. In the letter second read above, the Government of India have released the first instalment of Central share of Rs.4900.000 lakh which includes funds released under General category a sum of Rs.3920.00 lakh, SCSP category a sum of Rs.931.00 lakh and TSP category a sum of Rs.49.00 lakh for implementation of the National Horticulture Mission under Mission for Integrated Development of Horticulture Scheme (MIDH) during 2019-2020.
- 3. In the letter third read above, the Director of Horticulture and Plantation Crops has requested the Government to sanction and release a sum of Rs.8166.666 lakh which includes Government of India share of Rs.4900.00 lakh and State matching share of Rs.3266.666 lakh, towards the implementation of National

Horticulture Mission under Mission for Integrated Development of Horticulture for the year 2019-2020.

- 4. The Government, after careful examination, accept the proposal of the Director of Horticulture and Plantation Crops / Managing Director, Tamil Nadu Horticulture Development Agency and accordingly sanction and release a sum of Rs.8166.666 lakh (Rupees Eighty one crore sixty six lakh sixty six thousand and six hundred only) as first instalment which includes Government of India share of Rs.4900.00 lakh and State matching share of Rs.3266.666 lakh, towards the implementation of National Horticulture Mission under Mission for Integrated Development of Horticulture for the year 2019-2020 in Tamil Nadu.
