ORDER:

In the Government order first read above, administrative sanction for a sum of Rs.8.88 lakh and financial sanction for a sum of Rs.4.167 lakh, as 1st instalment, in the funding pattern of 60:40 between the Central and State Governments was accorded, [i.e. Government of India share Rs.2.50 lakh and State share Rs.1.667 lakh], towards implementation of Crop Diversification Programme, a sub scheme under Rashtriya Krishi Vikas Yojana during 2018-19.

2. In the letter 2nd read above, the Government of India have released an amount of Rs.2.83 lakh, as 2nd instalment of funds, for implementation of Crop Diversification Programme (CDP), under Rashtriya Krishi Vikas Yojana for replacing tobacco farming with alternate crops/cropping system during 2018-2019.

3. In the letter 3rd read above, the Director of Horticulture and Plantation Crops has requested to sanction a sum of Rs.4.713 lakh [i.e., Government of India Share Rs.2.83 lakh + State Share Rs.1.883 lakh] as 2nd instalment, for the project "Crop Diversification Programme, a Sub scheme, under Rashtriya Krishi Vikas Yojana, for replacing Tobacco farming with alternate crops/cropping system. The Executive Director, Tamil Nadu Watershed Development Agency has recommended the proposal. The component wise details are given below:-
