ORDER:

In the letter first read above, the Government of India have conveyed that a sum of Rs.5.33 lakh have been allocated as central share for implementation of Crop Diversification Programme (CDP) under Rashtriya Krishi Vikas Yojana for replacing tobacco farming with alternate crops/cropping system during 2018-2019 and requested to prepare intervention wise physical / financial targets and submit Annual Action Plan for the year 2018-2019, including central and state share.

2. In the Government letter 3rd read above, the Annual Action Plan for a sum of Rs.8.88 lakh (GOI share Rs.5.33 lakh + State share Rs.3.55 lakh) has been forwarded to the Government of India.

3. In the letter 5th read above, it has been conveyed by the Government of India that Annual Action Plan for the year 2018-19 has been approved, subject to the approval of State Level Sanctioning Committee (SLSC).

4. In the letter 6th read above, the Government of India have released an amount of Rs.2.50 lakh as 1st instalment of Government of India share for implementation of Crop Diversification Programme (CDP) under Rashtriya Krishi Vikas Yojana for replacing tobacco farming with alternate crops/cropping system during 2018-2019.

5. In the letter 8th read above, the Executive Director, Tamil Nadu Watershed Development Agency has stated that RKVY Division of Government of India, has rounded off figure as Rs.5.00 lakh as allocation, instead of Rs.5.33 lakh and the remaining Central share of Rs.2.83 lakh (Rs.5.33 lakh - Rs.2.50 lakh= Rs.2.83 lakh) will be released as second instalment.

6. The Director of Horticulture, in the letter 7th read above, has requested administrative sanction for the entire amount of Rs.8.88 lakh approved by the Government of India and financial sanction for an amount of Rs.4.167 lakh (GOI Share Rs.2.50 lakh + State Share Rs.1.667 lakh) as 1st first instalment for the project "Crop Diversification Programme under National Agriculture Development Programme / Rashtriya Krishi Vikas Yojana for "replacing Tobacco farming with alternate crops / cropping system" as Sub scheme under National Agriculture Development Programme 2018 - 19 to the department of Horticulture for implementation of the scheme as detailed below and the Executive Director, Tamil Nadu Watershed Development Agency has recommended the proposal.

The Government have examined the proposal of the Director of Horticulture and Plantation Crops and the Executive Director, Tamil Nadu Watershed Development Agency and accord administrative sanction for a sum of Rs.8.88 lakh (Rupees Eight lakh and Eighty Eight thousand only) and financial sanction for a sum of Rs.4.167 lakh (Rupees Four Lakh Sixteen Thousand and Seven hundred only) in the funding pattern of 60:40 between the Central and State Governments i.e. Government of India share Rs.2.50 lakh and State share Rs.1.667 lakh towards implementation of Crop Diversification Programme, a sub scheme under Rashtriya Krishi Vikas Yojana during 2018-19 as 1st instalment, subject to the condition that necessary approval has to be obtained in the ensuing 17th State Level Sanctioning Committee (SLSC).
