ORDER:-

In Government Order first read above, the Government have sanctioned a sum of Rs.411.77 lakh towards implementation of Integrated Horticulture Development Scheme (IHDS) in 9 Non - National Horticulture Mission (Non-NHM) Districts viz. Kancheepuram, Thiruvallur, Karur, Namakkal, Thiruvarur, Tuticorin, Nagapattinam, Thiruvannamalai and Virudhunagar for the year 2018-2019 under Mission for Integrated Development of Horticulture (MIDH) guidelines.

- 2. The Director of Horticulture and Plantation Crops in its letter second read above has sent a proposal to Government to bring more area of Horticulture Crops under Integrated Horticultural Development Scheme (IHDS) during 2018-2019 in 9 Non National Horticulture Mission (Non-NHM) Districts (viz, Kanchipuram, Karur, Namakkal, Nagapattinam, Thiruvarur, Tiruvallur, Thiruvannamalai, Tuticorin and Virudhunagar) at an amount of Rs.3136.77 Lakh under Mission for Integrated Development of Horticulture (MIDH) Norms. Under the scheme, focus will be given to area expansion of Vegetable crops, Fruit crops, Spices, Flower crops and Plantation crops. In respect of Vegetables and Flower crops, hybrid seed material and planting material will be distributed to farmers at 40% cost, upto 2 ha. In respect of Fruits, Spices and Plantation Crops, planting material and Seed & Seedlings of Spices will be distributed to farmers at 40% cost, upto 4 ha.
- 3. The Government, after careful examination of the proposal of Director of Horticulture and Plantation Crops, sanction for a sum of Rs.3136.63 lakh (Rupees thirty one crore thirty six lakh and sixty three thousand only) towards implementation of Integrated Horticulture Development Scheme (IHDS) in 9 Non National Horticulture Mission (Non-NHM) Districts viz. Kancheepuram, Thiruvallur, Karur, Namakkal, Thiruvarur, Tuticorin, Nagapattinam, Thiruvannamalai and Virudhunagar for the year 2019-2020 under Mission for Integrated Development of Horticulture (MIDH) guidelines and order accordings.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of accounts:-
