ORDER:-

Under the Mission for Integrated Development of Horticulture (MIDH), the Government of India have approved the Annual Action Plan 2018-2019 of National Horticulture Mission (NHM) at an outlay of Rs.16333.33 lakh in the funding pattern of 60:40 between the Centre and State to implement the scheme during 2018-2019.

2. In the Government order first read above, orders were issued sanctioning first installment for a sum of Rs.4166.67 lakh, which includes Government of India share-Rs.2500.00 lakh and State share-Rs.1666.67 lakh for implementation of the National Horticulture Mission under Mission for Integrated Development of Horticulture Scheme (MIDH) during 2018-2019.

- 3. In the Government order second read above, orders were issued sanctioning second installment for a sum of Rs.4000.00 lakh, which includes Government of India share-Rs.2400.00 lakh and State share-Rs.1600.00 lakh for implementation of the National Horticulture Mission under Mission for Integrated Development of Horticulture Scheme (MIDH) during 2018-2019.
- 4. In the Government order third read above, orders were issued sanctioning a sum of Rs.8333.33 lakh, which includes Government of India share-Rs.5000.00 lakh and State share-Rs.3333.34 lakh to implement the Special Package Action plan for Tamil Nadu 2018-2019 to mitigate the calamity arisen on account of Gaja Cyclone in Tamil Nadu under the Centrally Sponsored Scheme on Mission for Integrated Development of Horticulture (MIDH).
- 5. In the letter fourth read above, the Government of India have released its 3rd installment of Central share of Rs.3000.00 lakh [General category Rs.2400.00 lakh, Scheduled Caste Sub Plan (SCSP) category-Rs.570.00 lakh and Tribal Sub-Plan (TSP) category- Rs.30.00 lakh] for implementation of the National Horticulture Mission under Mission for Integrated Development of Horticulture Scheme (MIDH) during 2018-2019.
- 6. In the letter fifth read above, the Director of Horticulture and Plantation Crops / Managing Director, Tamil Nadu Horticulture Development Agency has requested the Government to sanction and release a sum of Rs.5000.00 lakh which includes Government of India share of Rs.3000.00 lakh and State matching share of Rs.2000.00 lakh as third installment towards implementation of National Horticulture Mission under Mission for Integrated Development of Horticulture for the year 2018-2019.
- 7. The Government after careful examination, accept the proposal of the Director of Horticulture and Plantation Crops / Managing Director, Tamil Nadu Horticulture Development Agency and accordingly sanction and release a sum of Rs.5000.00 lakh (Rupees Fifty crore only) as third installment (Government of India share of Rs.3000.00 lakh and State Matching share of Rs.2000.00 lakh) towards implementation of National Horticulture Mission under Mission for Integrated Development of Horticulture during 2018-2019 in Tamil Nadu.
