ORDER:-

In their letter first read above, the Government of India have approved the Annual Action Plan for implementation of National Horticulture Mission (NHM) programme in Tamil Nadu at an outlay of Rs.11500.00 lakh. Out of this, the Government of India share (85%) is Rs.9775.00 lakh and Government of Tamil Nadu share (15%) is Rs.1725.00 lakh.

2. In the Government Order second read above, the Government have sanctioned a sum of Rs. 7,56,52,900/-(15%) towards Government of India share of Rs.42,87,00,000 (85%) and released a sum of Rs.5,53,43,806/- after adjusting the accrued interest of Rs. 2,03,09,094/-.

3. In their letter third read above, the Government of India have released Rs.5000.00 lakh as second installment. Hence in his letter fourth read above, the Commissioner of Horticulture and Plantation Crops/Managing Director, Tamil Nadu Horticulture Development Agency has requested the Government to sanction a sum of Rs.882.353/- lakh as matching State share under National Horticulture Mission for 2013-2014. He has also stated that a sum of Rs.36,24,976/- has accrued as interest from the State share released for the year 2012-2013 under National Horticulture Mission.

4. The Government, after careful examination, accept the proposal of the Commissioner of Horticulture & Plantation Crops/Managing Director, Tamil Nadu Horticulture Development Agency, Chennai and accordingly sanction a sum of Rs.8,82,35,300/- (Rupees Eight Crore Eighty Two lakh Thirty Five Thousand and Three Hundred only) being the State Government's matching share(15%) towards the Government of India's share of Rs.50,00,00,000/- (Rupees Fifty Crore only) released as second installment during 2013-2014 for implementation of National Horticulture Mission (NHM) Scheme and release a sum of Rs.8,46,10,321/- (Rupees Eight Crore Forty Six lakh Ten Thousand Three Hundred and Twenty One only) after adjusting the accrued interest amount of Rs.36,24,979/- (Rupees Thirty Six lakh Twenty Four Thousand Nine Hundred and Seventy Nine only) earned towards the State share released by Government during 2012-2013 under National Horticulture Mission. The Commissioner of Horticulture and Plantation crops is also permitted to utilize the above interest amount to match the State Government share of Rs.8,82,35,300/- for implementation of the scheme.

5. The expenditure sanctioned in para-4 above, shall be debited to the following Head of Account:-

6. The Commissioner of Horticulture and Plantation Crops is authorized to draw the amount and deposit the same in the Personal Deposit account of Tamil Nadu Horticulture Development Agency by Contra Credit by following the procedures suggested in G.O.(Rt) No.1251, Finance (Ways and Means II) Department dated 30.12.2005 and G.O.(Rt) No.1253, Finance (Ways and Means II) Department, dated 30.12.2005.
