ORDER:

In the letter first read above, the Government of India has given approval, for implementation of Crop Diversification Programme (CDP) under Rashtriya Krishi Vikas Yojana for replacing tobacco farming with alternate crops/cropping system during 2020-21 and have allocated a sum of Rs.13.33 lakh (Rs.8.00 lakh Central share + Rs.5.33 lakh State share). The Government of India have also requested to prepare intervention wise physical / financial targets and submit action plan for the year 2020-21 including Central and State share.

2. In the Government letter 4th read above, the Annual Action Plan for an amount of Rs.13.33 lakh (Centre share Rs.8.00 lakh + State share Rs.5.33 lakh) for the year 2020-21 has been forwarded to the Government of India for allocation of funds for implementation of Crop Diversification Programme (CDP) under Rashtriya Krishi Vikas Yojana during 2020-21.

3. In the letter 5th read above, the Government of India have approved the Annual Action Plan under Crop Diversification Programme (CDP) a Sub Scheme of Rashtriya Krishi Vikas Yojana - RAFTAAR for the year 2020-21 for an amount of Rs.13.33 lakh (Centre share Rs.8.00 lakh + State share Rs.5.33 lakh)

4. In the letter 6th read above, the Government of India have released an amount of Rs.4.00 lakh as 1st instalment of Government of India share for implementation of Crop Diversification Programme (CDP) under Rashtriya Krishi Vikas Yojana for replacing tobacco farming with alternate crops / cropping system during 2020-21.

5. The Director of Horticulture and Plantation Crops, in the letter 7th read above, has requested financial sanction for an amount of Rs.6.67 lakh (Government of India Share Rs.4.00 lakh + State Share Rs.2.67 lakh) as 1st first instalment for the project "Crop Diversification Programme for "replacing Tobacco farming with alternate crops / cropping system" a Sub scheme under Rashtriya Krishi Vikas Yojana 2020-21 to the Department of Horticulture and Plantation Crops for implementation of the scheme.

6. In the letter 8th read above, the Executive Director, Tamil Nadu Watershed Development Agency has recommended the proposal of the Director of Horticulture and Plantation Crops and requested to accord administrative sanction for the entire amount of Rs.13.33 lakh as approved by the Government of India and financial sanction for a sum of Rs.6.67 lakh as 1st instalment for implementation of the following component:-

The Government have examined the proposal of the Director of Horticulture and Plantation Crops and the Executive Director, Tamil Nadu Watershed Development Agency and accord administrative sanction for a sum of Rs.13.33 lakh and financial sanction for a sum of Rs.6.67 lakh (Rupees Six Lakh Sixty Seven Thousand only) in the funding pattern of 60:40 between the Central and the State Governments (i.e. Government of India share Rs.4.00 lakh and State share Rs.2.67 lakh) towards implementation of Crop Diversification Programme, a sub scheme under Rashtriya Krishi Vikas Yojana during 2020-21.

8. The Component details and the head of account to which the expenditure sanctioned in para.7 above shall be debited are mentioned in the annexure to this order.

9. The Director of Horticulture and Plantation Crops is authorized to draw and disburse the amount sanctioned in para.7 above to the Managing Director, Tamil Nadu Horticulture Development Agency .

10. The Director of Horticulture & Plantation Crops is permitted to fix the Physical target based on the need and potential of the districts.

11. The Director of Horticulture & Plantation Crops is directed to follow the Rashtriya Krishi Vikas Yojana – RAFTAAR guidelines and furnish the monthly report to the Executive Director, Tamil Nadu Watershed Development Agency for onward transmission to Government of India.

12. This order issues with the concurrence of the Finance Department vide its U.O.No.27173/Fin(Agri)/2020, Dated 27.08.2020.


