ORDER:

In the letter second read above the Director of Horticulture and Plantation Crops has requested to sanction continuance of City Vegetable Development Scheme for implementation in Chennai City during the year 2009-10 at an outlay of Rs.6.00 lakh as it is an on-going Scheme.

2. The Government after careful consideration accord sanction of Rs.3.50 lakhs (Rupees three lakh and fifty thousand only) to continue the City Vegetable Development Scheme in Chennai Metropolitan City for the year 2009-10, subject to the condition that the cost of the scheme excluding the expenditure of Rs.50,000/- on vegetable campaign should be recovered in full through sale proceeds. The contemplated programme for the year 2009-10 is annexed to this order.
