



Agriculture – Horticulture – Part – II Scheme for 2012-2013 – Establishment of District Horticulture Extension and Training Centre at Erode and Trichy Districts during 2011-12 – Sanction of an additional amount of Rs.20.00 lakhs – Orders – Issued.

ORDER:

The Commissioner of Horticulture and Plantation Crops has sent a proposal for establishment of District Horticulture Extension and Training Centre at Erode and Trichy at a cost of Rs.20.00 lakhs.

- 2. In the G.O first read above, orders were issued sanctioning a sum of Rs.40.00 lakes for Establishment of District Horticulture Extension and Training Centre at Erode and Trichy under Part II Scheme for the year 2011-12.
- 3. In the letter third read above, the Commissioner of Horticulture and Plantation Crops has stated that for the Establishment of District Horticulture Extension and Training Centre at Erode and Trichy during 2011-12, a rough cost estimates were prepared based on the sanctioned amount of Rs.20.00 lakhs for each district. The plinth area was very much restricted than that was originally proposed. Both Erode and Trichy Districts have very high potential for horticultural crop area expansion in the coming years and technology oriented

schemes are to be implemented in nearly 4000 Ha each. Hence the Commissioner of Horticulture and Plantation Crops has requested an additional allotment of Rs.10 lakhs to each District (Erode & Triciny) for creating sufficient infrastructure for efficient running of the administrative machinery and proper implementation of the scheme components by the District Horticulture Extension & Training Centres to be constructed under Part-II Schemes 2012-13.

4. The State Planning Commission has recommended the above scheme of the Commissioner of Horticulture and Plantation Crops under Part-II Schemes 2012-2013 as detailed below:
