**ORDER:**

In the letter second read above the Director of Horticulture and Plantation Crops has requested to sanction the continuance of City Vegetable Development Scheme for implementation in Chennai City during the year 2010-11 at an outlay of Rs. 7.50 lakhs as it is an on-going Scheme.

2. The Government after careful consideration accord sanction of Rs. 3.50 lakhs (Rupees three lakhs and fifty thousand only) to continue the City Vegetable Development Scheme in Chennai Metropolitan City for the year 2010-11, subject to the condition that the cost of the scheme excluding the expenditure of Rs. 50,000/- on Vegetable campaign should be recovered in full through sale proceeds.
