Agriculture – Paramparagat Krishi Vikas Yojana (PKVY) under National Mission for Sustainable Agriculture (NMSA) – Administrative sanction for an amount of Rs.33.66 lakh and financial sanction for an amount of Rs.16.83 lakh for first year activities for implementation of development of 5 clusters (20 Ha each) in 2 aspirational districts of Ramanathapuram and Virudhunagar during the year 2020-21 – Orders – Issued.

## **ORDER:-**

In the reference first read above, the Government of India have conveyed an allocation of Rs.33.66 lakh (Central share is Rs.20.196 lakh and State share is Rs.13.464 lakh including 2% administrative charges of Rs.0.66 lakh) in the sharing pattern of 60:40 and have released 50 % central share of Rs.10.098 lakh to Tamil Nadu as first instalment for 1<sup>st</sup> year activities for the development of 5 clusters (20 Ha each) each in 2 aspirational districts of Ramanathapuram and Virudhunagar under Paramparagat Krishi Vikas Yojana (PKVY) component of National Mission for Sustainable Agriculture (NMSA) during the year 2020-21. The corresponding 40% State share works out to Rs.6.732 lakh. The Government of India have also informed that the clusters in aspirational districts under Paramparagat Krishi Vikas Yojana (PKVY) have to be implemented as per new Paramparagat Krishi Vikas Yojana (PKVY) guidelines.

2. Based on the above release made by the Government of India, in the letter 4<sup>th</sup> read above the Executive Director, Tamil Nadu Watershed Development Agency has sent a consolidated proposal received from implementing Departments (i.e. Director of Agriculture and Director of Horticulture and Plantation Crops vide

references 2<sup>nd</sup> and 3<sup>rd</sup> read above) The Executive Director, Tamil Nadu Wate shed Development Agency has stated that the Government of India have released the 50 % central share of Rs.10.098 lakh and the corresponding 40% State share works out to Rs.6.732 lakh for the first year activities of 5 clusters (20 Ha each) each in 2 aspirational districts of Ramanathapuram and Virudhunagar under Paramparagat Krishi Vikas Yojana (PKVY) component of National Mission for Sustainable Agriculture (NMSA) during the year 2020-21. 4. The Executive Director, Tamil Nadu Watershed Development Agency (TAWDEVA) has requested the Government to accord administrative sanction for an amount of Rs.33.66 lakh (Government of India share of Rs.20.196 lakh and State share of Rs.13.464 lakh including 2% administrative charges of Rs.0.66 lakh) and financial sanction for an amount of Rs.16.83 lakh (Rupees Sixteen lakhs and eighty three thousand only) (Government of India share of Rs.10.098 lakh + State share

Rs.6.732 lakh) based on the proposals given by the implementing Departme s of Agriculture & Horticulture and this includes to sanction a sum of Rs. 0.33 lakh out of the release of Rs. 16.83 lakh as first instalment to Tamil Nadu Watershed Development Agency to meet the administrative expenditure with regard to implementation of Paramparagat Krishi Vikas Yojana (PKVY) component of National Mission for Sustainable Agriculture (NMSA) in the State.

5. After careful examination, the Government accept the proposal of the Executive Director, Tamil Nadu Watershed Development Agency and accord administrative sanction for an amount of Rs.33:66 lakh (Government of India share of Rs.20.196 lakh and State share of Rs.13.464 lakh including 2% administrative charges of Rs.0.66 lakh) and financial sanction for an amount of Rs.16.83 lakh (Rupees Sixteen lakh and eighty three thousand only) (GOI share of Rs.10.098 + State share Rs.6.732) including 2% administrative cost to the tune of Rs.0.33 lakh to the Executive Director, Tamil Nadu Watershed Development Agency, for carrying out first year activities of 5 clusters (20 Ha each) each in 2 aspirational districts of Ramanathapuram and Virudhunagar under Paramparagat Krishi Vikas Yojana (PKVY) component of National Mission for Sustainable Agriculture (NMSA) scheme on 60:40 sharing basis during 2020-21, as detailed in Annexure I – III to this order.

6. The expenditure sanctioned in para 5 above shall be debited to the Heads of Account as given in Annexures I,II &III to this order.

7. Necessary additional funds will be provided in Revised Estimate / Final Modified Appropriation 2020-2021 under the relevant heads of account. Pending provision of such funds the Director of Agriculture the Director of Horticulture and Plantation Crops are authorised to draw and disburse the amount sanctioned in para 5 above to the concerned. The Director of Agriculture the Director of Horticulture and Plantation Crops are directed to include this expenditure while sending the Budget proposal for Revised Estimate / Final Modified Appropriation 2020 – 2021 to the Government in Finance (BG-I/Agri) Department at the appropriate time without fail.

8. The concerned Assistant Director of Agriculture is permitted to draw the advance amount as per the provisions under Article 99 of Tamil Nadu Financial Code, Volume I for conducting Trainings @ Rs.5,000 / Training / Cluster, Exposure visits @ Rs.5000/ Visit / Cluster and funds required for organic fair / melas /Exhibition and exposure visit for lead farmers.

9. The Director of Agriculture is permitted to appoint 1 Cluster Co-coordinator (Agricultural Graduate) under National Mission for Sustainable Agriculture (NMSA) – Paramparagat Krishi Vikas Yojana (PKVY) to manage the above mentioned activities for entire project are of 120 ha comprising in two Districts under 'Development of Man Power'.

10. The Director of Horticulture and Plantation Crops is authorized to draw and disburse the amount of Rs. 6.60 lakh and disburse the same to the Managing Director, Tamil Nadu Horticulture Development Agency authorized for implementing the project.

11. The Director of Agriculture is authorized to draw the 2% Administrative cost and disburse it to the Executive Director, Tamil Nadu Watershed Development

Agency for depositing into the savings Bank Account for incurring expenditure at Tamil Nadu Watershed Development Agency.

12. The Implementing Departments are requested to scrupulously foliow the Paramparagat Krishi Vikas Yojana (PKVY) Guidelines issued by the Government of India and to follow the cost norms and pattern of assistance while implementing the projects. Further the implementing Departments shall ensure proper implementation of the projects and complete them in time.

13. The Implementing Departments are also requested to monitor the implementation process and progress at the State & District levels effectively and to furnish the monthly progress reports to the Nodal Agency and to the Government simultaneously.

14. The Executive Director, Tamil Nadu Watershed Development Agency is requested to send the monthly progress report by 10<sup>th</sup> of the subsequent month and the utilization certificate in the prescribed format to the Government of India under intimation to this Government without fail.

15. This order issues with the concurrence of Finance Department vide its U.O.No.42144/Fin(Agri)/2020, dated 08.12.2020 and Additional Ledger No.1042 (One thousand and forty two).
