In the letters second read above, the Government of India have released the First installment of Central share of Rs. 5000.000 lakh which includes funds released under General category a sum of Rs.4000.00 lakh, SCSP category a sum of Rs.950.00 lakh and TSP category a sum of Rs.50.00 lakh for implementation of the National Horticulture Mission under Mission for Integrated Development of Horticulture Scheme (MIDH) during 2020-2021.
- 3. In the letter third read above, the Managing Director, Tamil Nadu Horticulture Development Agency has requested the Government to sanction and release a sum of Rs.8333.333 lakh which includes Government of India share of Rs.5000.00 lakh and State matching share of Rs.3333.333 lakh, towards the implementation of National Horticulture Mission under Mission for Integrated Development of Horticulture for the year 2020-21.

The Government, after careful examination, of the proposal of the Director of Horticulture and Plantation Crops / Managing Director, Tamil Nadu Horticulture Development Agency, hereby sanction and release a sum of Rs.83,33,33,300/-(Rupees Eighty Three crore Thirty Three lakhs, Thirty Three thousand and Three hundred only) as first installment which includes Government of India share of Rs. 5000.000 lakhs and State matching share of Rs. 3333.333 lakhs, towards the implementation of National Horticulture Mission under Mission for Integrated Development of Horticulture for the year 2020-21 in Tamil Nadu.
