## ORDER:

In the Government letter second read above, the Annual Action Plan at an outlay of Rs.269.20 lakh (Rs.112.4 lakh for 2020-2021 Rs.78.4 lakh for 2021-2022 and Rs.78.4 lakh for 2022 -2023) for developing 2000 ha under Bhartiya Prakritik Krishi Padhati (BPKP) of Paramparagat Krishi Vikas Yojana (PKVY) was sent to Government of India for approval.

2. In the reference 3<sup>rd</sup> read above, the Government of India have released an amount of Rs.31.0824 lakh to Tamil Nadu as first instalment for 1<sup>st</sup> year activities under Bhartiya Prakritik Krishi Padhati (BPKP) of Paramparagat Krishi Vikas Yojana (PKVY). The total release including the corresponding 40% State Share of Rs.21.216 lakh works out to Rs.53.04 lakh including 2% administrative charges of Rs.1.04 lakh.

3. In the reference 5<sup>th</sup> read above, the Executive Director, Tamil Nadu Watershed Development Agency (TAWDEVA) has forwarded the proposal of Director of Horticulture and Plantation Crops for the component wise amount proposed for implementing the first year programme along with State share for an outlay of Rs.106.08 lakh.

4. Bhartiya Prakritik Krishi Padhati (BPKP) is a zero external input system of organic agriculture largely relying on the principles of Zero Budget Natural Farming (ZBNF) is aimed at promoting traditional indigenous practices which gives freedom to farmers from externally purchased inputs and is largely based on, on-farm biomass recycling with major stress on biomass mulching, use of on-farm cow dung-urine formulations (such as Bijamrit and Jivamrit); time to time working for soil aeration and exclusion of all synthetic chemical inputs directly or indirectly. For ensuring certification under Participatory Guarantee System (PGS) India programme, Bhartiya Prakritik Krishi Padhati (BPKP) practices will be compliant to Participatory Guarantee System (PGS) - India standards.

Programme implementation:

The first-year activities of this programme will be implemented in 4 clusters in the Districts of Nilgiris, Coimbatore, Namakkal and Dindigul. The cluster size in each district will be 500 Ha by combining 2-3 adjacent blocks. Hence, this programme will be implemented in a total of 2000 Ha covering Horticultural crops.

The component wise amount proposed for implementing the first-year programme along with State matching share for an outlay of Rs.106.08 lakh is as below:

5. As per the National Mission for Sustainable Agriculture (NMSA) guidelines, the Tamil Nadu Watershed Development Agency, in the capacity of Nodal Agency for National Mission for Sustainable Agriculture (NMSA) is eligible for an amount of Rs.1.04 lakh (Rupees One lakh four thousand only) as 2% admin fund with regard to Implementation of Bhartiya Prakritik Krishi Padhati (BPKP) of Paramparagat Krishi Vikas Yojana (PKVY) component of National Mission for Sustainable Agriculture during the year 2020-2021 based on the release made by Government of India. Hence, the Executive Director, Tamil Nadu Watershed Development Agency has requested to sanction a sum of Rs.1.04 lakh, out of the release of Rs.53.040 lakh as first instalment to Tamil Nadu Watershed Development Agency (TAWDEVA) to meet the administrative expenditure with regard to Implementation of Bhartiya Prakritik Krishi Padhati (BPKP) of Paramparagat Krishi Vikas Yojana (PKVY) component of National Mission for Sustainable Agriculture (NMSA) in the State. She has also requested the Government to issue orders to Director of Agriculture to draw the administrative fund and transfer the same to Executive Director, Tamil Nadu Watershed Development Agency (TAWDEVA).

6. The Executive Director, Tamil Nadu Watershed Development Agency (TAWDEVA) has requested the Government to accord administrative and financial sanction for an amount of Rs.53.04 lakh (Rupees Fifty three lakh and four thousand only) including 2% administrative charges of Rs.1.04 lakh under Bhartiya Prakritik Krishi Padhati (BPKP) of Paramparagat Krishi Vikas Yojana (PKVY) as per the proposal given by the Department of Horticulture and Plantation Crops.

7. The Government after careful examination of the proposal of the Executive Director, Tamil Nadu Watershed Development Agency (TAWDEVA) accord administrative and financial sanction for an amount of Rs. 53.04 lakh (Rupees Fifty three lakh and four thousand only) including 2% administrative charges of Rs.1.04 lakh (i.e. Rs. 52.00 lakh + Rs.1.04 lakh) under Bhartiya Prakritik Krishi Padhati (BPKP) of Paramparagat Krishi Vikas Yojana (PKVY) in respect of first year programme for 4 clusters (2000 Ha) meant for the year 2020-2021 which shall be implemented during the year 2021-2022.

8. The expenditure sanctioned in para 7 above shall be debited to the heads of Account as given in Annexures to this order. The Director of Agriculture shall be Estimating, Reconciling and Controlling authority for the New Sub head of Accounts opened under Demand No. 05.02 as detailed in the Annexure – II to this order.

9. Necessary additional funds of Rs. 1,07,000/- will be provided in Revised Estimate (RE) / Final Modified Appropriation (FMA) 2021-2022. Pending provision of such funds, the Director of Agriculture is authorized to draw and disburse the amount sanctioned in para 7 above. The Director of Agriculture is directed to include this expenditure while sending the Budget proposal for Revised Estimate (RE) / Final Modified Appropriation (FMA) 2021-2022 to Government in Finance (Agriculture and Farmers Welfare) Department at the appropriate time without fail.

10. The Director of Horticulture and Plantation Crops is authorised to draw Rs.52.00 lakh (Rupees fifty two lakh only) and disburse the same to the Managing Director, Tamil Nadu Horticulture Development Agency (TANHODA) for implementing the project.

11. The Director of Horticulture and Plantation crops is permitted to fix the physical target based on the need and the potential of the Districts.

12. The Director of Horticulture and Plantation Crops is permitted to adhere the new procedure of fund flow through Public Financial Management System (PFMS) issued by Government of India and transferred to the single Nodal account for implementing the projects.

13. The Director of Agriculture is authorized to draw the 2% Administration Cost (i.e.) Rs.1.04 lakh (One lakh and four thousand only) and disburse the same to the Executive Director, Tamil Nadu Watershed Development Agency (TAWDEVA) for incurring administrative expenditure under Bhartiya Prakritik Krishi Padhati (BPKP) of Paramparagat Krishi Vikas Yojana (PKVY).

14. The Director of Horticulture and Plantation Crops is requested to scrupulously follow the Bhartiya Prakritik Krishi Padhati (BPKP) Guidelines issued by the Government of India and to follow the cost norms and pattern of assistance while implementing the projects. Further the implementing Departments shall ensure proper implementation of the projects and complete them in time.

15. The Director of Horticulture and Plantation Crops is also requested to monitor the implementation process and progress at the State and District levels effectively and to furnish the monthly progress reports to the Nodal Agency and to the Government simultaneously.

16. The Executive Director, Tamil Nadu Watershed Development Agency (TAWDEVA) is requested to send the monthly progress report by 10<sup>th</sup> of the subsequent month and the utilization certificate in the prescribed format to the Government of India under intimation to this Government without fail.

17. This order issues with the concurrence of Finance Department vide its U.O. No. 46211/Finance (Agriculture and Farmers Welfare) /2021, dated 01.12.2021 and Additional Sanction Ledger No.1012 (One thousand and twelve).
