### ORDER:-

The Government of India have tentatively allocated an amount of Rs.355.00 crore to State of Tamil Nadu as Central Share for implementation of Per Drop More Crop component of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) during the year 2018-2019 which includes Rs.300 crore for Micro Irrigation and Rs.55.00 crore for Other Intervention - water harvesting or water conservation activities.

In the Government order first read above, orders were issued releasing a sum of Rs.53555.07 lakh (Micro Irrigation – Rs.48983.41 lakh and Other Intervention – Rs.4571.66 lakh) which includes 60% Government of India share, 40% matching State share, additional share for Micro Irrigation including 12% GST towards first installment for implementation of Micro Irrigation and Other Intervention Scheme under Prathan Mantri Krishi Sinchayee Yojana during 2018-2019.

2. In the Government order second read above, orders were issued releasing a sum of Rs.27004.98 lakh (Micro Irrigation – Rs.24700.32 lakh and Other Intervention – Rs.2304.66 lakh) which includes 60% Government of India share, 40% matching State share, additional share for Micro Irrigation including 12% GST towards second installment for implementation of Micro Irrigation and Other Intervention Scheme under Prathan Mantri Krishi Sinchayee Yojana during 2018-2019.

3. In the Government order third read above, orders were issued for releasing a sum of Rs.15128.32 lakh (Rs.13836.66 for Micro Irrigation and Rs.1291.66 lakh for Other Intervention) as third installment for implementation of "Per Drop More Crop" component of Pradhan Mantri Krishi Sinchayee Yojana.

4. In the reference fourth read above, the Government of India have released Rs.3875.00 lakh (Rs.3275.00 lakh for Micro Irrigation and Rs.600.00 lakh for Other Intervention) as final installment for implementation of "Per Drop More Crop" component of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY). Along with a sum of Rs.7450.46 lakh and Rs.400.00 lakh have to be released as State Share for Micro Irrigation and Other Intervention respectively.

5. The Managing Director, Tamil Nadu Horticulture Development Agency (TANHODA) has requested the Government to sanction an amount of **Rs.10725.46 lakh** for Micro Irrigation and **Rs.1000.00 lakh** for Other intervention as final instalment towards implementation under Per Drop More Crop component of Pradhan Mantri Krishi Sinchayee Yojana for the year 2018-19 as follows:-



