### ORDER:

In the reference first read above, the Government of India have tentatively allocated an amount of Rs.340.00 Crore to Tamil Nadu as Central Share for implementation of "Per Drop More Crop" component of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) for the year 2019-2020. Out of the total allocation, 20% of the fund should be restricted to Other Intervention activities - Water harvesting or water conservation activities. The Other Intervention (OI) activities must be linked with Micro Irrigation for higher water use efficiency.

2. The Managing Director, Tamil Nadu Horticulture Development Agency in the letter third read above has stated that, for the year 2019-2020, it has been proposed to carry out Other Intervention - Supplementary Water Management Activities at a financial outlay of Rs.116.29 Crore and install Micro Irrigation system in an area of 2.28 lakh ha at a financial outlay Rs.1244.48 Crore in both Horticultural and Agricultural crops totaling to Rs.1361.00 Crore under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) "Per Drop More Crop" component. The fund release of Supplementary Water



Management Activities for the Horticulture and Agriculture will be carried by the concerned Departments. The details of the project are given below:-

4. The Managing Director, Tamil Nadu Horticulture Development Agency has requested the Government to sanction an amount of **Rs.295.33 Crore** (**Rs.262.00 Crore** for Micro Irrigation and **Rs.33.33 Crore** for Other Intervention - Supplementary Water Management Activities) as detailed below:-


