ORDERS :-

In the Government Order read above, order were issued for sanction and release of Rs.295.33 Crores as first installment including a sum of Rs.262.00 Crores and Rs.33.33 Crores for implementation of Micro Irrigation Scheme and Other Intervention activities respectively under Pradhan Mantri Krishi Sinchayee Yojana during 2019-20.

2. In the Government Order second read above, orders were issued for release a sum of Rs.307.00 Crores (Rs.272.47 Crore for Micro Irrigation and Rs.34.53 Crores for Other Intervention Supplementary Water Management Activities) which includes 60% Government of India share 40% matching State Share and additional share for Micro Irrigation including 12% GST towards balance amount of first installment for smooth and successful implementation for Micro Irrigation and Other Intervention Scheme under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) during 2019-2020.

3. In the letter third cited, the Government of India has released the balance fund of Rs.319 Crores for implementation of Micro Irrigation Scheme “Per Drop More Crop”, thus totaling to the allocation of Rs.523.00 Crores. The Total Financial allocation for the year 2019-20 is with the state additional share and mandatory share is given below:-

Out of the total allotment, Rs.255.20 Crores has been allotted for Micro Irrigation and Rs.63.80 Crores for Other intervention – Water harvesting or water conservation activities. The Matching State Share and Additional Share to be released by the State government corresponding to the PMKSY-PDMC Micro Irrigation fund for Final installment release of Central Share is given below:-

The Government after careful examination accept the proposal of the Managing Director, Tamil Nadu Horticulture Development Agency and sanction a sum of Rs.942.24 Crores (Rs.835.91 Crores for Micro Irrigation and Rs.106.33 Crores for Other Intervention – Supplementary Water Management Activities which includes 60% Government of India share, 40% matching State share and additional state share for Micro Irrigation including 12% GST towards balance amount of final instalment for smooth and successful implementation of Micro Irrigation and Other Intervention Scheme under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) as

detailed below, and release a sum of Rs.22544.58 Lakhs during 2019-20. The balance amount of Rs.71679.42 Lakhs shall be released in 2020-21.
