ORDER:

The Government of India have tentatively allocated an amount of Rs.340.00 crore to Tamil Nadu as Central Share for implementation of "Per Drop More Crop" component of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) for the year 2019-20. Out of the total allocation, 20% of the fund should be restricted to Other intervention activities - Water harvesting or water conservation activities. The Other Intervention (OI) activities must be linked with Micro Irrigation for higher water use efficiency. Further, an additional amount of Rs.183.00 Crore was allotted to Tamil Nadu as a central share for implementation of Per Drop More Crop Component of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY), now totaling the central share to Rs. 523.00 Crores.

- 2. In the Government Order first read above, orders were issued releasing a sum of Rs.295.33 Crores (Rs.262.00 Crore for Micro Irrigation and Rs.33.33 Crore for Other Intervention) which includes 60% Government of India share 40% matching State Share and additional share for Micro Irrigation including 12% GST towards first installment for smooth and successful implementation for Micro Irrigation and Other Intervention Scheme under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) during 2019-2020.
- 3. In the Government Order second read above, orders were issued releasing a sum of Rs.307.00 Crores (Rs.272.47 Crore for Micro Irrigation and Rs.34.53 Crores for Other Intervention Supplementary Water Management Activities) which includes 60% Government of India share 40% matching State Share and additional share for Micro Irrigation including 12% GST towards balance amount of first installment for smooth and

successful implementation for Micro Irrigation and Other Intervention Scheme under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) during 2019-2020.

- 4. In the Government Order third read above, orders were issued sanctioning a sum of Rs.942.24 Crores (Rs.835.91 Crores for Micro Irrigation and Rs.106.33 Crores for Other Intervention Supplementary Water Management Activities which includes 60% Government of India share, 40% matching State share and additional state share for Micro Irrigation including 12% GST towards balance amount of final instalment for smooth and successful implementation of Micro Irrigation and Other Intervention Scheme under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) and released a sum of Rs.22544.58 Lakhs during 2019-2020. The balance amount of Rs.71679.42 Lakhs shall be released in 2020-21.
- 5. The Managing Director, Tamil Nadu Horticulture Development Agency has now requested the Government to release the balance amount of Rs.716.7942 Crore for implementation of "Per Drop More Crop" component of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) for the year 2019-2020. The category wise share for the balance amount is given as detailed below:-

- 10. The Managing Director, Tamil Nadu Horticulture Development Agency is directed to release the funds sanctioned in para-6 above for Micro Irrigation and Other Intervention for the implementing departments.
- 11. The Managing Director, Tamil Nadu Horticulture Development Agency is directed to follow the operational guidelines of Micro Irrigation.
- 12. He is also directed to send the progress report on the details of achievement made, utilization of funds of the Centre / State share released for the above said scheme and also to send the utilization certificate in respect of funds sanctioned in this order to Government of India.
