ORDER:

In the reference second read above, the Government of India have tentatively allocated an amount of Rs.400.00 crore to Tamil Nadu as Central Share for implementation of "Per Drop More Crop" components of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) for the year 2020-21. Out of the total allocation, 20% of the fund should be restricted to other intervention activities - Water harvesting or water conservation activities. The Other Intervention (OI) activities must be linked with Micro Irrigation for higher water use efficiency.

2. The Managing Director, Tamil Nadu Horticulture Development Agency in the letters fourth read above has stated that, the Micro Irrigation Scheme will be implemented through Tamil Nadu Horticulture Development Agency (TANHODA) as Nodal Agency. Department of Agriculture and Department of Sugar will be Project Implementing Agencies for their respective crops and Agricultural Engineering Department will take up measurement of the Micro Irrigation installed fields of Horticultural, Agricultural and Sugarcane Crops. The details of the project are given below:-

The Government of India have now released an amount of Rs.240.00 crore as first installment as Central Share for implementation of "Per Drop More Crop" component of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) during the year 2020-21. Out of the total allotment, Rs.192.00 crore has been allotted for Micro Irrigation Scheme and Rs.48.00 crore for Other intervention - Water harvesting or water conservation activities.

4. The Director of Agriculture in the letter first read above has requested to accord Administrative sanction for a sum of Rs. 150.00 crore and Financial sanction for a sum of Rs. 93.94 crore as additional cost assistance to sugarcane under State Fund for installation of surface/subsurface drip in sugarcane during 2020-21 since, the amount of Rs. 12.39 crore sanctioned vide G.O. (Ms) No. 238, Agriculture (H1) Department, dated 14.10.2019 and the balance amount of Rs. 56.06 crore is kept with him as unspent amount.

5. The Managing Director, Tamil Nadu Horticulture Development Agency has requested the Government to release an amount of Rs.858.78 crore (Rs.778.78 crore for Micro Irrigation (including sugarcane) and Rs.80.00 crore for Other intervention - Supplementary Water Management Activities) as first installment for implementing "Per Drop More Crop" component of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) for the year 2020-21 as per the category mentioned for Micro Irrigation and Other intervention - Supplementary Water Management Activities below:-

6. The Government after careful examination, of the proposal of the Managing Director, Tamil Nadu Horticulture Development Agency hereby accord Administrative sanction for a sum of Rs.858.78 crore (including sugarcane) and financial sanction for a sum of Rs.400.00 crore [Government of India share Rs.240.00 crore (60%) and State Mandatory share Rs.160.00 crore (40%)] as first installment for smooth and successful implementation of Micro Irrigation and Other Intervention Scheme under Pradhan Mantri Krishi Sinchayee Yojana during 2020-2021. The Government also permits the Director of Agriculture to utilize the unspent amount of Rs.56.06 crore for sugarcane available with him.

8. Necessary additional funds of Rs. 320.00 crore will be provided in RE/FMA 2020-21. Pending provision of such funds, the Director of Horticulture and Plantation Crops is authorized to draw and disburse the amount sanctioned in para 6 above. However, the expenditure shall be brought to the notice of the Legislature by **Specific Inclusion** in the Supplementary Estimate 2020-21. The Director of Horticulture and Plantation Crops is directed to include this expenditure while sending the Budget Proposal for RE/FMA 2020-21 and also to send necessary draft explanatory notes for including the above expenditure in the Supplementary Estimates 2020-2021 to Government in Finance (BG-I/Agri.) Department at the appropriate time without fail.

9. The Director of Horticulture and Plantation Crops is authorized to draw the amount sanctioned and released in para-6 above and deposit the same in the Personal Deposit account of Tamil Nadu Horticulture Development Agency by Contra Credit by following the procedures laid down in G.O.(Rt) No.1251, Finance (Ways and Means II) Department, dated 30.12.2005 and G.O.(Rt) No.1253, Finance (Ways and Means II) Department, dated 30.12.2005.

10. The Managing Director, Tamil Nadu Horticulture Development Agency is directed to release the funds sanctioned in para 5 above for Micro Irrigation and Other Intervention for the implementing departments.

11. The Managing Director, Tamil Nadu Horticulture Development Agency is directed to follow the operational guidelines of Micro Irrigation.


