ORDER:

In the reference first read above, the Government of India have tentatively allocated an amount of Rs.400.00 Crore to Tamil Nadu as Central Share for implementation of "Per Drop More Crop" component of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) for the year 2020-21. Out of the total allocation, 20% of the fund should be restricted to other intervention activities - Water harvesting or water conservation activities. The Other Intervention (OI) activities must be linked with Micro Irrigation for higher water use efficiency.

2. The Micro Irrigation Scheme will be implemented through Tamil Nadu Horticulture Development Agency (TANHODA) as Nodal Agency. Department of Agriculture and Department of Sugar will be Project Implementing Agencies for their respective crops and Agricultural Engineering Department will take up measurement of the Micro Irrigation installed fields of Horticultural, Agricultural and Sugarcane Crops. The allocation for 2020-21 for Micro Irrigation and Other intervention is furnished below:-

In the Government order second read above, orders were issued according Administrative sanction for a sum of Rs.858.78 crore (including sugarcane) and financial sanction for a sum of Rs.400.00 crore [Government of India share Rs.240.00 crore (60%) and State share Rs.160.00 crore (40%)] as first installment for smooth and successful implementation of Micro Irrigation and Other Intervention Scheme under Pradhan Mantri Krishi Sinchayee Yojana during 2020-2021. The Government also permitted the Director of Agriculture to utilize the unspent amount of Rs.56.06 Crore for sugarcane available with him.

- 4. In the Government order fourth read above, orders were issued sanctioning a sum of Rs. 378.72 Crore (PMKSY Rs. 308.78 Crore and Sugarcane Rs.69.94 Crore) as balance amount of first instalment for implementation of Micro Irrigation under the scheme of "Per Drop More Crop" component of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) and additional cost assistance for installation of sub-surface / surface drip in sugarcane during 2020-2021.
- 5. In the Government order eighth read above, orders were issued sanctioning a sum of Rs.177.20 Crore [Rs. 157.20 Crore for Micro Irrigation and Rs.20.00 Crore for Other Intervention Scheme] which includes 60% Government of India share, 40% matching State share, State additional share for Micro Irrigation including 12% GST as second installment for smooth and successful implementation of Micro Irrigation and Other Intervention Scheme under Prathan Mantri Krishi Sinchayee Yojana during 2020-2021.
- 6. In the Government Order third read above, amendment orders were issued for identification and Registration of beneficiaries for sub-surface drip irrigation from 80% to 50% and surface drip irrigation from 20% to 50% and in the letter fifth read above, the Director of Agriculture has stated that, the financial allocation for Sugarcane additional cost assistance for the year 2020-21 has been revised from Sugarcane additional cost assistance for the total allocation of Rs.126.00 Crore, Rs.150.00 Crore to Rs.126.00 Crore. Out of the total allocation of Rs.126.00 Crore, Rs.69.94 Crore was released and a balance Rs.56.06 Crore is required to implement the Sugarcane Additional Cost Assistance during 2021-22.
- 7. In the reference sixth read above, the Government of India had released Rs.100.00 Crore (Rs.80.00 Crore (80%) for Micro Irrigation and Rs.20.00 Crore (20%) is for Other Intervention Supplementary Water Management Activities) as Third installment for implementation of "Per Drop More Crop" component of Pradhan Mantri Krishi Sinchayee Yojana.
- 8. In the reference seventh read above, the Managing Director, Tamil Nadu Horticulture Development Agency has requested the Government to release an amount of Rs.318.06 Crore for Micro Irrigation and Rs.33.33 Crore for Other intervention totaling to an amount of Rs.351.39 Crore (including Sugarcane) for implementing "Per Drop More Crop" component of PMKSY for the year 2020-21 as per the category mentioned for Micro Irrigation and Other intervention Supplementary Water Management Activities as given below:-
