Order:-

In the reference first read above, the Government of India approved the Annual Action Plan for the year 2019-20 under Restructured National Bamboo Mission at an outlay of Rs.236.25 lakh with the funding pattern between Central and State Government as 60:40.

2. In the reference second read above, the Government of India have released the first instalment of Rs.90.75 lakh to the State Government of Tamil Nadu as a Central Share during 2019-20 for implementing the National Bamboo Mission (NBM) under National Mission for Sustainable Agriculture (NMSA).



The Director of Horticulture and Plantation Crops has requested the Government to release Rs.151.25 lakh (Government of India share of Rs.90.75 lakh along with matching State share of Rs.60.50 lakh) as per the category mentioned above for the smooth and successful implementation of National Bamboo Mission for the year 2019-20 under National Mission on Sustainable Agriculture (NMSA). The details of Category-wise release of funds are as detailed below:-

- 4. The Government after careful examination, decided to accept the proposal of the Director of Horticulture and Plantation Crops and accordingly sanction a sum of Rs.151.25 lakh which includes 60% Government of India share of Rs.90.75 lakh and 40% matching State share of Rs.60.50 lakh for smooth and successful implementation of National Bamboo Mission under National Mission on Sustainable Agriculture (NMSA) for the year 2019-2020.

- 6. Necessary additional funds of Rs.1,51,25,000/- will be provided in Revised Estimate/Final Modified Appropriation 2019-2020. Pending provision of such funds, the Director of Horticulture and Plantation Crops is permitted to draw and disburse the amount sanctioned in para 4 above. However, the expenditure shall be brought to the notice of the Legislature by specific inclusion in the Supplementary Estimate. The director of Horticulture and Plantation Crops is directed to include this expenditure while sending the Budget proposal for Revised Estimate/Final Modified Appropriation 2019-2020 and also to send necessary explanatory notes for including the above said expenditure in the Supplementary Estimates 2019-2020 to Government in Finance (BG-1/Agri) Department at the appropriate time without fail.
- 7. The Director of Horticulture and Plantation Crops is permitted to deposit the amount sanctioned in para 4 above in the Personal Deposit account of Tamil Nadu Horticulture Development Agency by Contra Credit by following the procedures suggested in G.O.(Rt).No.1251, Finance (Ways and Means II) Department dated 30.12.2005 and G.O.(Rt) No.1253, Finance (Ways and Means II) Department, dated 30.12.2005.
- 8. The Managing Director, Tamil Nadu Horticulture Development Agency is directed to release the funds sanctioned in para 4 above for the implementation of National Bamboo Mission under National Mission on Sustainable Agriculture (NMSA) for the year 2019-2020.
- 9. The Managing Director, Tamil Nadu Horticulture Development Agency is directed to follow the instructions issued by the Government of India in para 4 of the reference first read above.
- 10. He is also directed to send the progress report on the details of achievement made, utilization of funds of the Centre / State share released for the above said scheme and also to send the utilization certificate in respect of funds sanctioned in this order to Government of India.
