Order:-

In the reference first read above, Government of India has approved the State Annual Action Plan for the year 2020-21 to implement National Bamboo Mission under National Mission for Sustainable Agriculture for an amount of Rs.149.81 Lakh (Gol share + State Share).

2. In the reference second read above, orders were issued sanctioning a sum of Rs.75.00 lakh which includes 60% Government of India share of Rs.45.00 lakh and 40% matching State share of Rs.30.00 lakh as first installment for smooth and successful implementation of National Bamboo Mission under National Mission on Sustainable Agriculture (NMSA) for the year 2020-2021.

3. In the reference third read above, Government of India have released the second installment amount of Rs.22.44 Lakh for the year 2020-21 in three Heads of Account (General +SC+ST). The matching state share of Rs.14.960 Lakh (40%) is arrived out for the central share of Rs.22.44 lakh (60%).

4. The Managing Director, Tamil Nadu Horticulture Development Agency has requested the Government to release an amount of Rs.37.400 lakh (which includes Government of India share of Rs.22.44 lakh + State share of Rs.14.960 lakh) for implementation of area 2nd year Maintenance 170 Ha of Bamboo plantation raised during 2019-20 under National Bamboo Mission. 
