#### ORDER:

In the reference first read above, orders were issued sanctioning a sum of Rs.75.00 lakh which includes 60% Government of India share of Rs.45.00 lakh and 40% matching State share of Rs.30.00 lakh for implementation of National Bamboo Mission under National Mission on Sustainable Agriculture for the year 2020-2021.

2. In the reference second read above, Government of India has approved the State Annual Action Plan for the year 2021-2022 to implement National Bamboo Mission under National Mission for Sustainable Agriculture for an amount of Rs.583.54 Lakh (Government of India share – Rs.350.12 Lakh + State Share – Rs.233.42 Lakh).

- 3. In the reference third read above, Government of India have released the first instalment amount of Rs.175.00 Lakh for the year 2021-2022 in three Heads of Account (General +SC+ST). The matching State share of Rs.116.666 Lakh (40%) is arrived out for the central share of Rs.175.00 Lakh (60%).
- 4. In the reference fourth read above, the Managing Director, Tamil Nadu Horticulture Development Agency has requested the Government to release an amount of Rs.291.666 lakh (which includes Government of India share of Rs.175.00 lakh + State share of Rs.116.666 lakh)for implementation of National Bamboo Mission for the year 2021-2022. The details of release of funds are as detailed below:-

- 7. Necessary additional funds of Rs.11,93,000/- will be provided in Revised Estimate/Final Modified Appropriation 2021-2022. Pending provision of such funds, the Director of Horticulture and Plantation Crops is authorized to draw and disburse the amount sanctioned in para 5 above. However, the above expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimate 2021-2022. The Director of Horticulture and Plantation Crops is directed to include this expenditure while sending the Budget proposal for Revised Estimate/Final Modified Appropriation 2021-2022 and also send necessary Draft Explanatory notes for Specific Inclusion in the Supplementary Estimates 2021-2022 to Government in Finance (BG-1/Agri&F.W) Department at the appropriate time without fail.
- 8. The Government authorize the Director of Horticulture and Plantation Crops to draw the fund sanctioned in para-5 above and permit him to transfer the funds to the single Nodal Account for State Linked Scheme as per the new procedure

of fund flow through Public Financial Management System (PFMS) issued by Government of India for implementing the projects.

- 9. The Managing Director, Tamil Nadu Horticulture Development Agency is directed to release the funds sanctioned in para 5 above for the implementation of National Bamboo Mission under National Mission on Sustainable Agriculture (NMSA) for the year 2021-2022.
- 10. The Managing Director, Tamil Nadu Horticulture Development Agency is directed to follow the instructions issued by the Government of India in para 4 of the reference second read above.
- 11. He is also directed to send the progress report on the details of achievement made, utilization of funds of the Centre /State share released for the above said scheme and also to send the utilization certificate in respect of funds sanctioned in this order to Government of India.
- 12. This order issues with the concurrence of the Finance Department vide its U.O.No.57773/Finance(Agri & F.W)/2021, dated: 03.01.2022 and ASL Number 1330 (One-thousand three hundred and thirty).
