ORDER:-

Under Mission for Integrated Development of Horticulture (MIDH), the Government of India had approved the Annual Action Plan 2019-2020 of National Horticulture Mission (NHM) at an outlay of Rs.163.333 Crore in the funding pattern of 60:40 between the Centre and State, and communicated the approved physical and financial target for each component under Annual Action Plan -2019-2020.

- 2. In the Government Order first read above, orders were issued sanctioning a sum of Rs.8166.666 lakh as first instalment which includes Government of India share of Rs.4900.00 lakh and State matching share of Rs.3266.666 lakh, towards the implementation of National Horticulture Mission under Mission for Integrated Development of Horticulture for the year 2019-2020 in Tamil Nadu.
- 3. In the letter second read above, the Government of India have released the second instalment of Central share of Rs. 4000.000 lakh which includes funds released under General category a sum of Rs.3200.00 lakh, Schedule Caste Sub

Plan category a sum of Rs.760.000 lakh and Tribal Sub Plan category a sum of Rs.40.00 lakh for implementation of the National Horticulture Mission under Mission for Integrated Development of Horticulture Scheme (MIDH) during 2019-2020.

- 4. In the letter third read above, the Managing Director, Tamil Nadu Horticulture Development Agency has requested the Government to sanction and release a sum of Rs.6666.665 lakh which includes Government of India share of Rs.4000.00 lakh and State matching share of Rs.2666.665 lakh, towards the implementation of National Horticulture Mission under Mission for Integrated Development of Horticulture for the year 2019-2020.
- 5. The Government, after careful examination, accept the proposal of the Director of Horticulture and Plantation Crops / Managing Director, Tamil Nadu Horticulture Development Agency and accordingly sanction and release a sum of Rs.66,66,66,500/-(Rupees Sixty Six crore Sixty Six lakh and Sixty Six thousand and Five hundred only) as second instalment which includes Government of India share of Rs.4000.00 lakh and State matching share of Rs.2666.665 lakh, towards the implementation of National Horticulture Mission under Mission for Integrated Development of Horticulture for the year 2019-2020 in Tamil Nadu.
- 6. The expenditure sanctioned in para-5 above, shall be debited in the Revised Estimate 2019-2020 under the following Head of Accounts:-
