Horticulture – Centrally Sponsored Scheme on National Horticulture Mission Programme under Mission for Integrated Development of Horticulture during 2019-2020 – Release of Third Instalment of Rs.401.570 Lakh by Government of India – Sanction and release of a sum of Rs. 669.282 Lakh including state share of Rs.267.712 Lakh as Third Installment – Orders – Issued.

### ORDER:-

Under Mission for Integrated Development of Horticulture (MIDH), the Government of India had approved the AAP 2019-20 of National Horticulture Mission (NHM) at an outlay of Rs.163.333 Crore in the funding pattern of 60:40 between the Centre and State, and communicated the approved physical and financial target for each component under AAP -2019-2020

2. In the Government Order first read above, orders were issued sanctioning a sum of Rs.8166.666 lakh as first instalment which includes Government of India share of Rs.4900.00 lakh and State matching share of Rs.3266.666 lakh, towards the implementation of National Horticulture Mission under Mission for Integrated Development of Horticulture for the year 2019-2020 in Tamil Nadu.



3. In G.O.(Ms.) No. 30, Agriculture (H1.1)Department, dated. 03.02.2020 orders were issued sanctioning a sum of Rs.6666.665 lakh as second instalment which includes Government of India share of Rs.4000.00 lakh and State matching share of Rs.2666.665 Lakh, towards the implementation of National Horticulture Mission under Mission for Integrated Development of Horticulture for the year 2019-2020 in Tamil Nadu.

4. In the letters third read above, the Government of India have released the Third instalment of Central share of Rs. 401.570 lakh which includes funds released under General category a sum of Rs. 321.27 lakh, SCSP category a sum of Rs. 76.300 lakh and TSP category a sum of Rs. 4.000 lakh for implementation of the National Horticulture Mission under Mission for Integrated Development of Horticulture Scheme (MIDH) during 2019-2020.

5. In the letter fourth read above, the Managing Director, Tamil Nadu Horticulture Development Agency has requested the Government to sanction and release a sum of Rs.669.29 lakh which includes Government of India share of Rs.401.57 lakh and State matching share of Rs.267.712 lakh, towards the implementation of National Horticulture Mission under Mission for Integrated Development of Horticulture for the year 2019-20.

6. The Government, after careful examination, hereby sanction and release a sum of Rs.669.282/- **(Rupees Six Crore Sixty Nine lakhs and Twenty Eight thousand and Two hundred only)** as third instalment which includes Government of India share of Rs. 401.57 lakh and State matching share of Rs. 267.712 lakh, towards the implementation of National Horticulture Mission under Mission for Integrated Development of Horticulture for the year 2019-20 in Tamil Nadu.


